- 01. CALL TO ORDER BY PRESIDING OFFICERS** – The meeting was opened at 5:30 p.m. by Travis Tschaenn, Brownsburg Town Council President and Judy Kenninger, Brownsburg Park Board President.
- 02. PLEDGE OF ALLEGIANCE**
- 03. ROLL CALL**
 - 03.01** Brownsburg Town Council – Travis Tschaenn, Matt Simpson, Jeff Gracey and Ben Lacey were all present. Brian Jessen was not present. Also present were Ann Hathaway, Clerk Treasurer; Jeff Eder, Town Manager; Al Geans, Assistant Town Manager; and Travis Tranbarger, Director of Parks and Recreation.
 - 03.02** Brownsburg Park Board – Judy Kenninger, Kent Fillinger, Cari Palma, Amy Hobrock, Matthew Freije and Michael Zonder were all present.
- 04. TOPICS OF DISCUSSION AND ITEMS FOR CONSIDERATION**
 - 04.01** Public Forum to discuss the proposed Youth Sports project on a future park on County Road 700 N and County Road 900 E. Presentations were given as follows:

Hendricks County Commissioner Dennis Dawes gave a presentation. His presentation pertained to how this project will fit along the Ronald Reagan Parkway corridor. Travis Tschaenn asked if the County was willing to help fund this project. Mr. Dawes stated he would take the question back to the Commission.

Travis Smith, 6473 Tradition Drive and Robert Baldwin, 599 Windborough gave the presentation on behalf of the Brownsburg Little League Baseball and Brownsburg Girls Softball regarding the Brownsburg Youth Sports, LLC. The presentation included previous financials and the future financial outlook. Mark Schell, 30 Mulberry Court and former League President, discussed concessions. Questions were answered regarding the financials of the League and Economic Impact.

Travis Tranbarger discussed the Economic Impact Study and Management Plan.
 - 04.01** Consideration of Such Other Matters that May Come Before the Park Board and/or the Town Council of the Town of Brownsburg.

The council and park board broke out into small groups to receive public input and to answer questions. The meeting reconvened at 7:33 p.m.

Dr. Jim Snapp, Superintendent Brownsburg Community School Corporation, discussed the agreement between the Town and the School Corporation. The School Board is not interested in deviating from the agreement made in December.
